When the NBRC investment in real property is for improvements, rehabilitation, construction, etc. and said investment is \$250,000 or greater, a Notice of Federal Interest is also required to be filed in the appropriate official records of the jurisdiction where the property is located. The NFI must be recorded and provided to NBRC before requesting a reimbursement of funds under the award.
